Subject Tariffs Peak Supply 2026 clarification

Dear Sir, Madam,

As a result of Article 3.64 of the Energy Act and Article 3.30 of the Energy Decree, GTS is obliged to make arrangements for peak supply to suppliers serving small consumers (consumption categories G1A and G2A). Peak supply is described as "All provisions regarding gas purchase, flexibility services and gas transport in the national gas transport grid required to enable permit holders to provide peak supply to all residential customers in the Netherlands".

Each year we contract the facilities that are necessary to provide the Peak Supply to residential customers. With this letter we inform you about the tariffs that will be applied for providing the Peak Supply in 2026. A description of the applied calculation method can be found on our website ([Peak Supply - GTS website](#)).

The resulting and applicable tariffs for the peak supply service in 2026 are:


